

## OMCC EVENT INDEMNITY/DECLARATION FORM

**PLEASE READ CAREFULLY BEFORE SIGNING. BY SIGNING THIS FORM, YOU ARE CONFIRMING THAT YOU UNDERSTAND AND AGREE TO THE FOLLOWING PARAGRAPHS AND DECLARATIONS WHICH ARE DESIGNED TO CREATE A LEGALLY BINDING RELATIONSHIP IN RETURN FOR YOUR BEING ALLOWED TO PARTICIPATE**

### MOTORSPORT CAN BE DANGEROUS AND MAY INVOLVE INJURY OR DEATH

In consideration for being permitted to participate in the Event:

1. I acknowledge and realise that participation in the Event is potentially dangerous and that there are inherent risks associated with my participation. I accept that, despite Odiham Motorcycle Club ('OMCC') taking all reasonable precautions, damage or injury may occur. I acknowledge and voluntarily accept these risks and take part in the activity at my own risk.
2. I hereby declare that I am in good health and I do not suffer from any medical condition or disability which is likely to affect my normal control of a motorcycle, or which makes it unsafe for me to ride or otherwise participate in the Event. I am not taking drugs (prescribed or otherwise) or alcohol that will impair my ability to take part and I will not participate in the Event whilst under the influence of alcohol or intoxicating drugs.
3. I hereby declare that I am competent and able to take part in the Event and that my eyesight (with appropriate corrective lenses if required to be worn) is to the standard required for a road riding test.
4. I accept that I shall be solely responsible for any decision that I might make as to fitness to participate in the event at any time throughout the day.
5. I hold a current full driving licence entitling me to use on the public roads in the U.K, for a motorcycle of the size and type that I will be using on the circuit and have produced it to OMCC for inspection.
6. I understand that I must be 18 years of age or over to participate in this Event and hereby declare that I am not below the age of 18 years.
7. I will satisfy myself (by sighting lap or otherwise) before taking part in any on-track activity that the circuit is acceptable to me with regards to its features and physical layout.
8. Any motorcycle for which I am responsible for and/or which I will be using during the Event is in good and suitable mechanical condition, fit for the purpose for which I have attended the Event and that it meets the safety standards required by law (if applicable).
9. Full protective equipment and clothing must be always worn by me whilst using my motorcycle.
10. The use of my motorcycle is entirely at my risk and I accept responsibility for any damage caused to my motorcycle (whether controlled by me or any other person).
11. I accept that should the organisers have to move my motorcycle during the Event, every care will be taken not to (further) damage it, but they are not liable for any accidental damage caused during the moving of the motorcycle.
12. I understand that the OMCC are not liable for any loss of circuit time due to circumstances that come under the control of the circuit management and decisions that they may take.

13. I understand that the organisers are not responsible for any adverse weather conditions and any affect this may have on the event.

14. I understand that the organisers and the OMCC committee reserve the right to remove me from the circuit at any time if they consider my actions to be dangerous or detrimental to other circuit users, or not representing the best interests of OMCC. The manner of my machine control whilst out on circuit shall be courteous towards other circuit users.

15. I accept that I am not participating in a timed speed trial or competition type event.

16. I accept that if I decide to ask for any form of advice or instruction, I am solely responsible for my actions during and thereafter.

17. I accept that I am totally responsible for my actions and accept that I am responsible for my safety and the safety of others around me whilst taking part in this Event.

18. No claim of any kind arising from my own negligence, error or omission or otherwise (including without limitation in respect of any damage to any motorcycle or other equipment I intend to use at the Event) shall be made by me, my guests or on my behalf or on behalf of any of my dependants against RAF Odiham, OMCC , the organisers, any instructor(s) or any company or organisation connected with the Event ('Relevant person') or any of their respective employees, agents or assistants, or any other participant in the Event.

19. Neither OMCC nor any other Relevant person shall be liable for any loss, damage, claims, costs, expenses, injury or demands suffered directly or indirectly by me as a consequence of my attendance at or participation at the Event provided that nothing in this form shall exclude OMCC or any Relevant person's liability for personal injury or death caused by its negligence. I shall reimburse OMCC and other Relevant persons against any loss or liability suffered by them as a result of my error, default, act or omission.
